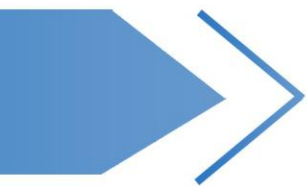

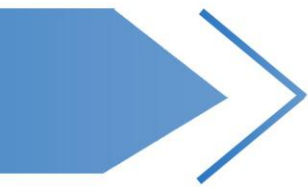


# OUR ORGANIZATION STRUCTURE



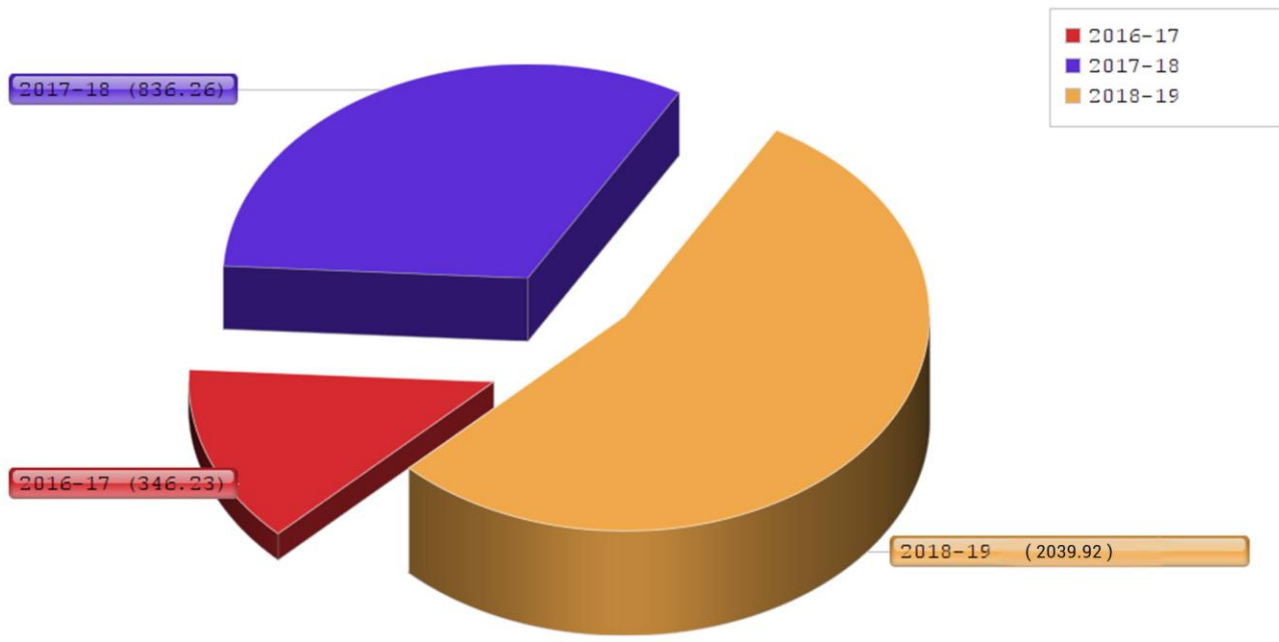
